TERMS AND CONDITIONS FOR CERTIFIED AVIATION SECURITY SERVICE PROVIDERS

1. The holder of this certificate shall ensure full compliance with the Private Security Regulation Act, 2016.
2. Any Aviation Security Inspector or person appointed by the Director General of Kenya Civil Aviation Authority shall be allowed unhindered access at all times to the premises in the occupation or control of the holder of this certificate and premises of any of the operators where the certificate holder is contracted for purposes of examining the operations, documents, equipment, tools, materials, personnel or certificate, or for purposes of carrying out security inspections, audits and testing functions pursuant to regulations 5(2), 6 and 79 of the Civil Aviation (Security) Regulations, 2020.
3. The holder of this certificate shall furnish the Director General of Kenya Civil Aviation Authority, their Security Programme or Procedures for approval and shall conduct its business in accordance with the agreements and approved security programme(s) of the operator(s), the Civil Aviation (Security) Regulations, the National Civil Aviation Security Programme as revised from time to time and any other applicable national laws or regulations.
4. The holder of this certificate is authorized by the Director General of Kenya Civil Aviation Authority to conduct aforesaid business with operators within the civil aviation industry in Kenya who shall only recognize and deal with such certified service providers.
5. The holder of this certificate shall comply with any orders, circulars and directives issued by the Authority prescribing any aviation security matter for purposes of better carrying out or enhancing the objects and purposes of the Civil Aviation (Security) Regulations or the National Civil Aviation Security Programme.
